#### Violations

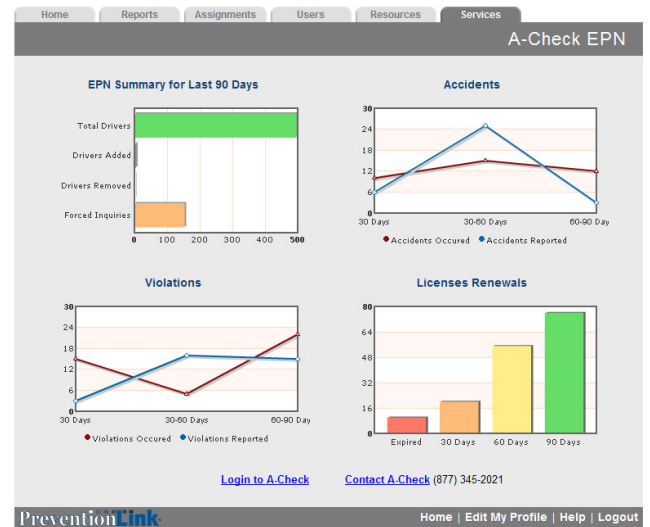
- Violations reported and violations by date
